Competition Handbook

At the last meeting it was noted that in Part II – Provincial Competition Duties, the "Duties of the Chief Steward" section of the draft Handbook had been changed from:

NOTE: All Judges should be selected from the BC Guild of Wine Judges.

To:

NOTE: All Judges should be selected from the BC Guild of Wine Judges. If a non BCGWJ person is deemed to be "equivalent to a wine judge" or if trainee is used, then they should be paired with a certified BCGWJ to maintain consistency.

The concern was over who would deem such equivalency and John McMaster volunteered to contact the Guild for clarification. Mary Homer (Guild Master) replied that she agreed that the "equivalent to a wine judge" should be removed and offered the following replacement:

"Any BCAWA club Competition Chief Stewards are asked to select wine judges for their competition from the BC Guild of Wine Judges. The Competition Chief Steward is to contact the Statistician for the BC Guild of Wine Judges to determine in which varietals or classes each of the Qualified Judges, Newly-certified Judges, and Trainees are certified.

All Qualified Judges should be placed to judge the wine varietals in which they are qualified, whenever possible.

Newly-certified Judges and Trainees may also be placed to judge wine varietals in which they are qualified, provided they are paired with a Qualified Judge in that same varietal.

Newly-certified Judges and/or Trainees that are not qualified in any varietals (as at the date of the subject competition) should be utilized as wine stewards and given the opportunity to participate fully at the judging table alongside the other two qualified Judges."

Note 2:

Class Z. Provincial Crush

In the 2019 Provincial Competition this class will consist of wines made from the 2017 Provincial Crush which was Jessie Grove Zinfandel grapes.

Entries must be made from 100% Zinfandel grapes received through the Provincial Crush program. No blending is allowed.

While winemakers could choose to make any style of wine from the grapes, for the purpose of this competition the intended style of the wine is dry red, with a description similar to that of E4, but with the restrictions noted in the paragraph above.
